## FACTSHEET ON INTERNATIONALISATION SKILLS (iSKILLS) TALENT DEVELOPMENT PROGRAMME

To address the training and skills needs of SMEs looking to internationalise, the International Trading Institute at Singapore Management University (ITI@SMU) has designed the Internationalisation Skils (iSkills) Talent Development Programme with Ngee Ann Polytechnic (NP) as its knowledge partner, supported by SkillsFuture Singapore (SSG).

## Details of iSkills Talent Development Programme

- The one-year pilot phase of the Programme, to be conducted by ITI@SMU and NP, adopts an applied learning model that combines classroom, online and experiential learning. Participants will take part in real-life project work with guidance from mentors, experience overseas immersion modules, and participate in country clinics and sharing sessions with business and industry leaders.
- Participating companies can send their employees to gain the necessary skills to support their internationalisation plans. These companies can also take on new hires from the pool of interested applicants. Individuals may apply for the iSkills programme and have the opportunity to be placed with interested internationalising companies. Successfully placed individuals will then undergo the iSkills programme as new hires. Applicants can indicate their interest via the ITI@SMU's website.
- The curriculum is designed to meet the skills needs of employees of various levels. iSkills Talent Development Programme 1 caters to senior management level participants, while the iSkills Talent Development Programme 2 caters to junior and middle management participants.
