## [SSG CIRCULAR/MIPD/2021/4]: Reminder for Registered Training Providers to Comply with the Training Management System (TMS) Requirement by 31 December 2021

12 November 2021

- This circular is a reminder for all Registered Training Providers (TPs) who receive SSG Funding for Funded Course(s) under the SkillsFuture Singapore Agency Terms for Training Providers ("TP T&Cs"). All TPs shall comply with the TMS requirement (see below) by 31 December 2021. Failure to comply with the TMS requirement may result in SSG exercising any or all of its rights under the TP T&Cs (which may include the withholding of any or all SSG Funding).
- With reference to the circulars sent on <u>13 July 2020</u> and <u>15 January 2021</u>, all SSG-funded TPs are required to adopt a TMS linked to SSG's system to facilitate data transfer to process training claims. Exemption from the TMS requirement applies only to the following TPs stated below:
  - (i) In-house approved training organisations;
  - (ii) Overseas massive open online course providers;
  - (iii) Government institutions offering only SkillsFuture Credit course(s); and
  - (iv) TPs offering SkillsFuture Credit- Only (SFC-only) courses supported by Ministry of Education (MOE)-funded institutions and other public agencies, aside from SSG. This is to accelerate productivity improvement in the Training and Adult Education (TAE) sector through streamlining of data submission and grant disbursements interfacing with TPGateway.

## Minimum Integration Areas Needed for Core Training Grant Disbursement

 To fulfil the TMS requirement, TPs would need to ensure that their TMS is integrated with SSG systems to perform core functions which facilitate training grant disbursement. Please refer to <u>Table 1</u> below for the minimum integration areas. TPs can access the <u>SSG</u> <u>Developer Portal</u> to browse the Application Programming Interface (API) documentation, guides and sample codes for more information.
